## **COMEDK UGET 2025 : Centralised single window counseling for Engineering & Architecture courses**

Based on the mandate given by the Karnataka Un-aided Private Engineering Colleges Association (KUPECA), COMEDK's Under Graduate Entrance Test for Engineering Courses (UGET – 2025) was conducted on 10.05.2025 and 25.05.2025 and results were announced today (i.e. on 07.06.2025.)

Now, the COMEDK has decided to start the process of counseling and hereby invites interested candidates who have qualified in COMEDK UGET to register for counseling which will be conducted in accordance with the schedule published.

The following will be the eligibility criteria:

"Passed in 2nd PUC / 12th Standard examination with English as one of the Languages and obtained a minimum of 45% of marks in aggregate with Physics and Mathematics as compulsory subjects along with Chemistry / Bio-Technology / Biology / Electronics / Computer Science (40% for SC, ST and OBC candidates of Karnataka State only). Relaxation in minimum academic eligibility (i.e. 45% to 40%) is applicable only to Karnataka Candidates".

Similarly, as per the Council of Architecture, the eligibility criteria for admission to 1st year of 5 year B.Arch degree course for the academic session 2025-26 will be as under:

1) No candidate shall be admitted to Architecture course unless she/he has passed 10+2 or equivalent examination with Physics and Mathematics as compulsory subjects along with either Chemistry or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Engineering Graphics or Business Studies with at least 45% marks (40% in case of SC/ST/OBC) in aggregate or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 45% marks in aggregate (40% in case of SC/ST/OBC).

" 2) The Candidate has to qualify an Aptitude Test in Architecture conducted either by NTA (i.e. JEE) or NATA conducted by the Council for admission to the Architecture degree course" and there is no separate entrance test conducted by COMEDK for admission to Architecture course.

The above eligibility criteria apply to B. Plan and B. Design course also.

There are two types of upper limit of tuition fee. The tuition fee for the academic year 2025-26 is provided hereunder:

- 1. ₹2,81,100/-
- 2. ₹2,00,000/-

The tuition fee along with the "Other fees" will be collected by COMEDK during the counseling. There is a cap on the skill lab fees that will be collected by individual colleges apart from the University fees.

The COMEDK counseling is conducted based on the directions issued by the Hon'ble Admission Overseeing Committee vide its communication dtd. 27.08.2021 regarding process to be followed by COMEDK for conducting the counseling.

The above key points are brought out just to give a fair idea to the aspiring candidates. **Detailed counseling process document is hosted on COMEDK website separately which has to be gone through for all details**. Also, a separate document consisting the mandatory documents required for verification during counseling is also hosted on COMEDK website. The candidates interested in participating the counseling are advised to get these documents scanned and upload the same after registering for counseling besides mobilizing the funds required for payment after allotment of seats.

The candidates are required to refer to the COMEDK's official website <u>www.comedk.org</u> only for all updates.
